He then went on to Cranbrook Academy of Art in Bloomfield Hills, Michigan, where he attained his MFA in painting and was awarded a merit scholarship.

As an artist, Lloyd Eddy has shown nationally. His work has been showcased in Artistik Magazine. He has been in group shows, juried shows and solo shows. Lloyd has participated in community art events, artist cooperative galleries, charity benefits, and is a member of the College Art Association.

Lloyd has been teaching college art, design, and humanities for 12 years. He has taught at St. Clair County Community College, Oakland Community College, IADT, Gibbs College and Saginaw Valley State University. He currently is an Assistant Professor of Art and Humanities at Lake Superior State University.

2017 SHOW SCHEDULE

- April 10th Deadline for artist submissions and entry fee payment. *Any entries received after April 10th will not be accepted.*
- April 18th Artists will be notified if their artwork has been juried into the show.
- April 29th Accepted artwork must be delivered to Alberta House by 4 pm.
- May 2nd Exhibit opens.
- May 5th Reception and awards from 5 to 7 pm.
- May 31st Exhibit closes.
- June 1st - 17th Entries may be picked up at Alberta House Tuesday through Saturday, 11 am to 4 pm. Artwork unclaimed after May 13th will become the property of the Olive M. Craig Gallery unless other arrangements have been made by the artist in advance.

Artist's Choice is a juried exhibit open to all artists.

All work must be original in composition. No reproductions, patterns, or kits will be accepted. Print-making media must have been hand-pulled by the artist. Two-dimensional artwork must be suitably framed and ready for hanging. Three-dimensional work must be self-supporting and ready to display. All artwork must have been completed within the last two years and not previously exhibited at Alberta House Arts Center.

Conditions

- Artists may submit up to three works in any media. There are no size limitations, although size may become a consideration in final judging.
- All artwork must be for sale at the price listed on the entry form. The Olive M. Craig Gallery will retain 30% commission on all works sold.
- Artwork must be identified on the reverse side **(or on the base of 3D work) with the artist's name and title of the work.** Please indicate which side is the top.
- Artwork may not be removed from the exhibit prior to the closing date.
- The Olive M. Craig Gallery has the right to reject any artwork that does not meet the requirements of the exhibit, is not adequately prepared to hang or display, or may be a hazard to viewers (for example, the work has sharp edges or is unstable).
- The Olive M. Craig Gallery and the Sault Area Arts Council are not responsible for loss, theft, or damage to artwork.

ENTRY PROCEDURE

New for 2017: We are accepting entries only by email. The jurors will only view photos. Good quality photos taken with a cell phone are acceptable.

Artists may submit up to 3 pieces. (Diptychs and triptychs count as one piece.)

You may submit up to 2 images for each 2D piece and up to 3 images for each 3D piece that you are entering.

- Each image must be saved as a JPEG file.
- Images can be no longer than 6 inches in any direction, and may be no larger than 300 dpi.
- Label each JPEG file with entry number (1a, 1b, etc. for multiple views), plus the title of the piece. **DO NOT include artist's name in the file or on the image.**
- Fill out entry form and scan it.

- Mail entry fee with a copy of your entry form to Alberta House (address below). Checks should be made payable to the Olive M. Craig Gallery. This must be received by April 10th.
